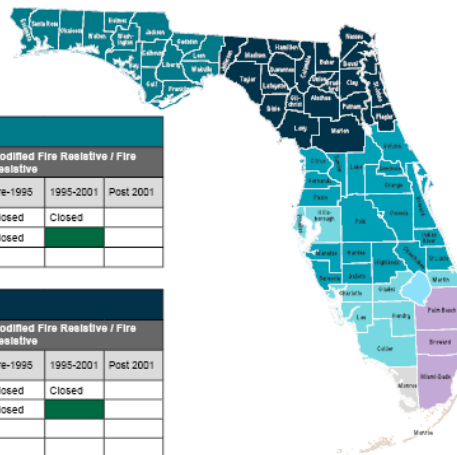

As a reminder, we previously expanded the below guidelines in recent weeks:

- Effective 10/13/2023 for new business we have increased the maximum TIV to \$6.5M in Florida, Louisiana, and Texas for risks with Joisted Masonry, Masonry Non-Combustible, Fire-Resistive, or Modified Fire Resistive construction.

AND

- All Florida renewal quotes (effective 11/2/2023 onward) will be released 20 days prior to the effective date, providing an additional five days for reviews. Effective 10/13/2023, Florida new business quotes may be quoted up to 20 days prior to the effective date as well. All other states will continue to be released 35 days prior to the effective date.
