- **B.** In the event a suit is filed, we agree to submit to the jurisdiction of any court of competent jurisdiction within the United States in which the suit may be brought. Nothing in this condition constitutes or should be understood to constitute a waiver of our right to enforce an Arbitration Provision, commence an action in any court of competent jurisdiction in the United States to remove an action to a United States District Court or to seek a transfer of a case to another court as permitted by the laws of the United States or of any state in the United States.
